AGREEMENT TO PARTICIPATE (FOR VOLUNTEER PARTICIPANTS) IN THE LEUKAEMIA FOUNDATION'S 2011 MISSION TO CURE PLANE PULL

INTRODUCTION

1. I,.....(Pull participant, please print)

HEREBY AGREE with the persons associated with or members of the organisations and/or committees, the organisations and/or committees themselves and the bodies corporate, whose names appear in Schedule 1 (hereinafter collectively called "the organiser") that I am by this agreement entitled to participate in the event listed in Schedule 2 (hereinafter called "the meeting") at the venues listed at Schedule 3 (hereinafter called "the venues") on the terms and conditions set out in this document.

ACKNOWLEDGEMENT OF RISKS, DANGERS AND OBLIGATIONS

2. **I ACKNOWLEDGE** that Plane Pulling is dangerous and that by engaging in the activity and participating in the charity Plane Pull I take and am exposed to certain risks and dangers including, but not limited to:
- (a) that I may be injured, physically or mentally, and may be killed;
 - (b) that other participants may participate dangerously or with lack of skill;
 - (c) that event conditions may be hazardous and may vary without warning or predicability;
 - (d) that organisers, officials, airport operators and any agents or representatives of those in charge of the meeting are frequently obliged to make decisions under pressure of time and/or events;
 - (e) that any policy of insurance of or in respect of my life or physical or mental health may be avoided;
 - (f) that there may be no or inadequate facilities for treatment or transport of me if I am injured.

INDEMNITY GIVEN TO ORGANISERS

3. **IN CONSIDERATION** of the acceptance of me as an entrant in the Plane Pull **I AGREE THAT:**
- (a) I participate in the Plane Pull at my sole risk and responsibility;
 - (b) I accept the venue as it stands with all or any defects hidden or exposed;
 - (c) I have an obligation to myself and to others to participate safely and within the rules of the event;
 - (d) I will indemnify and hold harmless the organisers, their respective servants, agents or officials against any action or claims which may be made by me or on my behalf or by other parties for or in respect of or arising out of my death or any injury loss or damage caused to me or to my machinery or equipment whether caused by negligence, breach of contract or in any other manner whatsoever.
